Contract for Consulting Services with HRHC

R. Budris discussed the Medical Needs Exercise that was conducted using the UASI Public Health tent system at the Essex County facility located in Cedar Grove. In preparation for this exercise, a shared services agreement was approved by the board. On motion by V. DeFilippo, second by S. Bastola, Resolution #16-06-01 (Attachment 4) was unanimously approved formalizing a contract with Hudson Regional Health Commission for shared services to assist ERHC with the Medical Needs Sheltering Exercise (Attachment 5). Funding for the agreement was through the 2015-2016 Public Health Emergency Preparedness Grant.

Authorize Entering into Public Health Emergency Preparedness Contract

Resolution # 16-06-03 authorizing ERHC to to participate in the Public Health Emergency Preparedness ("PHEP") grant of \$282,004 (Attachment 6) was passed unanimously on a motion from K. Costello and a second by S. Portuese. The board reviewed the final Request For Proposals for this grant (Attachment 7).

RFP for Public Health Consultant

As the contract with Epi Intel & Health Research Planning LLC will expire on July 31, 2016 a motion was made by V. DeFilippo and seconded by S. Portuese, unamioulsy carrried, to issue a Request for Proposals (RFP) for public health consulting services from August 1, 2016, to July 31, 2018 (Attachment 8). A second motion was made by M. Raimo and seconded by V. DeFilippo, unamiously carried, to authorize the Executive Director, in consultation with the Finance and Personnel Committee to award the contract

Medical Reserve Corps Contract

The Commission successfully won a competitive grant for \$15,000 for a Medical Reserve Corps grant to strengthen the ability of Essex County Shelters to handle special needs populations (Attachment 9). Resolution #16-06-02 authorizing this grant was passed unanimously on a motion by T. DeNova and a second by C. Britton (Attachment 10).
